7.	I have read and understood the avionics/ instrumentation manuals, in particular use of GPS/ moving map displays to avoid airspace infringements.	
8.	I have been signed off by a Club instructor to act as P1 following a dual check.	
9.	I have received a ground briefing for each type on which I am not current from a Club instructor or person nominated by them.	
10.	I will inform the duty instructor of my intentions before each flight and follow their advice.	
11.	Before each flight I will assess conditions and forecast changes for the day and only fly if I am sure these are compatible with my experience and capability. If in doubt, I will err on the side of caution.
